From the lens of the Massachusetts Department of Elementary and Secondary Education, this Session will focus On Discussing: What Are the New Requirements for School Districts specific to the Implementation, Accountability, Procedures and Student Services Associated with the New Discipline Law?

#### &Plenary Session-Out of District Placements &

Featuring: Dr. Tom Hehir, Professor of Practice at Harvard Graduate School of Education, his associate, Dr. Todd Grindal, having completed his doctorate recently at Harvard, along with Marcia Mittnacht, the State Director for Special Education at the Department of Elementary and Secondary Education.

This session will focus on the Massachusetts Department of Elementary and Secondary Education continuing efforts to analyze Massachusetts special education out-of-district placement student data. It will review the latest findings (from research conducted by Dr. Hehir and Associates) on the Massachusetts special education data including discussion on potential long and short term recommendations for Massachusetts. It will also highlight the challenges and opportunities for school districts and students with disabilities in out of district placements.

This session will provide an overview of the lessons learned from districts and a review of the full implementation timeline (for all districts) with a particular focus on the role of **student** and **staff feedback** and **District-Determined Measures** in the new evaluation system of all educators. This session will help educators to better learn how to use these components of the evaluation system as tools for informing instruction and leadership, as well as highlight strategies and techniques for district implementation. Session participants will have the opportunity to provide feedback on ideas around potential implementation challenges related to both student and staff feedback and District-Determined Measures and engage in discussion.
