() **VOTING MEMBERSHIP** is open to LEA Administrators of Special Education and their Assistants, and to Collaborative Administrators

Dues are \$275 each year. Voting Members must also join CEC/CASE separately through those organizations' billing procedures ... see <http://www.cec.sped.org/mb> for details

() **ACTIVE MEMBERSHIP** is open to LEA Administrators of Special Education and their Assistants, and to Collaborative Administrators. (Non-Voting Membership) **Dues are \$275 each year.**

() **ASSOCIATE MEMBERSHIP** (non-voting membership and not eligible to hold office) is open to professionals in other areas of special education and in related services. **Dues are \$250 each year.**

() **RETIREES** annual membership **Dues are \$125.** **IMPORTANT NOTE:** *Individuals, although retired from municipalities or agencies, who continue to assume special education administrative/supervisory duties via compensation from another agency/company or LEA, are not eligible for Retired Membership, but are eligible for Voting, Active or Associate Membership.*

- ✓ In the event that a different person cannot replace a registrant for the **Fall** or **Winter** conference, ASE can grant a credit to another conference within the same fiscal year provided that ASE receives in writing via fax (781-742-7278) or email (contactase@asepage.org) **the request no later than 14 business days prior to the conference.**
- ✓ Spring Conference registrations can be transferred to another person you designate from your school district. **There are no credit applications for the Spring Conference if you are unable to attend.**
- ✓ **No other credit requests will be honored.**

ASE MULTIPLE MEMBER BENEFIT DISCOUNT

The Multiple Member Benefit Discount Opportunity **closes prior to our October 28, 2022 Conference**. This discount opportunity allows for additional professionals from your district, school or agency who becomes a 2021-2022 ASE Voting or Active Member and registers for all three ASE Conferences to receive a discount.

For additional professionals from your district to be eligible for the discount, your district must have at least one 2022-2023 ASE Voting or Active Membership along with the selection of all three conferences at a total of \$800.

The Multiple Member Benefit Discount Opportunity rate for additional Voting and Active Memberships, along with the registration for all three ASE Conferences **will be reduced from \$800 to \$706.50.**
